INSTRUCTIONS FOR COMPLETING POWER OF ATTORNEY

Enter all blanks on Power of Attorney form as stated below:

- (1) Employer Identification Number (EIN), also known as the Federal Tax Identification Number (Fill in this blank if the Grantor is not an individual)
- (2) Social Security Number (Fill in this blank if grantor is an individual)
- (3) Customs Assigned Number (Fill in this blank if Grantor does not have an Employer Identification Number or Social Security Number)
- (4) Print (or type) the full legal name associated with the registered Employer Identification or Social Security Number. If a partnership, list names of all partners.
- (5) Is the Grantor an individual, partnership, corporation, or sole proprietorship?
- (6) State, or country and province if a foreign Grantor, in which the Grantor is doing business.
- (7) Complete physical address where the Grantor resides (US Customs does not accept PO Boxes as valid addresses.
- (8) Signature of a duly authorized person of the company: President, Treasurer, Vice President, Corporate Secretary, CEO, CFO, CIO, COO (By signing this document, the signatory attests that he or she has authority to issue this power of attorney on behalf of the company or individual).
- (9) Capacity or Title of the signatory (e.g. President, Vice President, Treasurer, Corporate Secretary, CEO, CFO, CIO, COO, Partner, Member, Director of other Duly Authorized Representative).
